**HUNTING ORDINANCE**

BE IT RESOVLED: Hunting with, or the discharge of, a center fire rifle is unlawful within the following described areas:

SECTION 1. Beginning at the junction of Highway M-22 and Portage Point Drive: Thence Northwesterly along Portage Point Drive to Ivanhoe Drive: to the Lake Michigan Shoreline: Thence Southerly to Portage Lake Entry: Thence Easterly along the north shore of Portage Lake to the West 1/4 Section Line of section 26, T23N, R16W, Thence Northerly along the 1/4 Section Line to the Point of Beginning.

Hunting with, or the discharge of, a center-fire rifle is unlawful within the following described area: Beginning at the junction of highway M-22 and Portage Point drive; thence northwesterly along Portage Point drive to Ivanhoe drive, thence northwesterly along Ivanhoe drive in section 21, T23N, R16W, to the Lake Michigan shoreline; thence southerly to Portage Lake entry; thence easterly along the north shore of Portage lake to the west 1/4 section line of section 26, T23N, R16W; thence northerly along the 1/4 section line to the point of beginning.


