ORDINANCE NO. 99-06

**AN ORDINANCE TO AMEND, IN PART, ORDINANCE NO. 96-1, AN
ORDINANCE STYLED "AN ORDINANCE TO PROVIDE FOR THE
VOLUNTARY CONNECTION TO A PUBLIC SANITARY SEWER SYSTEM
TO BE LOCATED IN THE TOWNSHIP; ETC." BY AMENDING CERTAIN
DEFINITIONS THEREIN AND TO REPEAL
ALL ORDINANCES IN CONFLICT HEREWITH**

THE TOWNSHIP OF ONEKAMA ORDAINS:

Section 1. Section 1 - Definitions, Subsection A. of Ordinance No. 96-1, styled "An Ordinance to Provide for the Voluntary Connection to a Public Sanitary Sewer System to be Located in the Township; etc." is hereby amended to read, in its entirety, as follows:

A. "Public sanitary sewer system" or "system" means the sanitary sewer system used or intended for use by the public for the collection and transportation of sanitary sewage for treatment or disposal and owned by the Village and consisting of approximately 1,450 lineal feet of 6 inch force main in Highway M-22 from the existing manhole at Prospect Street in the Village to Portage Point Road and approximately 2,730 lineal feet of 6 inch force main in Portage Point Road from Highway M-22 to the property belonging to Little Eden Camp and Little Eden Campground Association, a Michigan non-profit corporation, located in Section Twenty-two (22) of Onkama Township and also consisting of approximately 1,694 lineal feet of 4 inch and/or 6 inch force main in Highway M-22 between Eight Mile Road and the entrance to the Onkama Shores Subdivision, in Section Thirty-six (36) of Onkama Township, and all related equipment and appurtenances.

Section 2. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed to the extent of the conflict and no further.

Section 3. Effective Date. This Ordinance shall be effective immediately upon publication as provided by law.
